- Welcome - Meeting started at 7:54am by president Maggie Dundon.
- Administrators' Reports - Michelle Rawson - I can't believe that we are into the middle of April. Testing at the school was so amazing. Amendment One - Each member of the Board shall have one vote. If a quorum is met at any meeting, at least fifty one percent ( $51 \%$ ) of the votes (unless otherwise specifically provided by these By-Laws) of those Board members voting shall decide any matter submitted for vote. If a directorship is being held by more than one person, only one vote counts.

Add to 9.3: At the discretion of the executive board, the executive board may decide to use an appropriate online option to conduct a vote in connection with a regular meeting

Amendment Four to the By-Laws discussion:
